1. RELIEF / EDUCATION SUPPORT ACTIVITIES:

A. COVID Relief activities:

The Government had announced continuous lock down during the Corona Virus pread, at the stage PMSSS took necessary steps to protect the beneficiaries and also approached various funding agencies to protect the people from the lack of foods in the project areas. The details are

Caritas India - New Delhi:

With the support of Caritas India, COVID Dry Ration Kits distributed in the 9 project plages of Puducherry and Villupuram Districts to the tune of Rs. One lakh. PMSSS Executive Director distributed the dry ration kits such as 5 kgs of rice, ½ kg of toor laterally kg of Bengal gram dhal, ½ kg of sugar, ½ kg of chilli powder, 1 kg of salt, 1 laterally cooking oil, 1 tea powder packet, 1 washing soap and 1 bathing soap to the laterally 200 persons (17 PwDs, 89 BPL, 13 orphan children, 6 single laterally members benefitted.

Feeding India - Chennai:

Feeding India in collaboration with the Caritas India has contributed 7500 kgs of rice and 2000 kgs of toor dhal in 31 villages of Puducherry, Cuddalore, Villupuram and Kallakuruchi Districts. Around 500 persons of (70 PwDs, 134 BPL, 106 schedule caste, 39 Old age, 62 widows, 33 refugees, 3 transgender, 42 Agri coolies, 4 street family and 7 single head). Totally 2039 family members benefited.

SPICMA - Special Project in Christian Missionary Areas, London:

Most. Rev. Dr. Antony Anandarayar, Archbishop of Pondicherry and Cuddalore Archdiocese cum the president of PMSSS recommended this project, SPICMA to grant the financial assistance of Rs. 4,66,883 to PMSSS towards the COVID 19 emergency response relief work. 555 persons from 16 villages of Villupuram District, 40 persons from Pennadam village of Cuddalore District, 35 persons from Puducherry District received dry ration kits such as 5 kgs of rice, ½ kg of toor dhal, ½ kg of Bengal gram dhal, ½ kg of sugar, ½ kg of chilli powder, 1 kg of salt, 1 litre of cooking oil, 1 washing soap and 1 bathing soap.

The relief kits were distributed by the Most. Rev. Dr. Anonty Anandarayar, Archbishop of Pondicherry and Cuddalore, Puducherry Assembly speaker Thiru. Lakshmi Narayanan, MLA.

In presence of PMSSS Vice President, Very. Rev. Fr. Arulnandhan, PMSSS procurator Rev. Fr. Gregory Lousis Joseph, PMSSS Executive Director, Principal of Petit Seminar School Rev. Fr. Bascal raj and PMSSS Admin cum Finance Officer. Totally 600 frontline workers, 2903 family members benefitted.

COVID 19 - Contribution received in kind through volunteers:

- Mr. John Kumar, MLA, Kamaraj Nagar, Puducherry donated 250 kgs of Rice,
 50 kgs of Wheat flour, 50 kgs of sugar to 50 beneficiaries of Kunankuruchi and Periyakuruchi project villages.
- Madame Shanthe, Puducherry contributed 250 kgs of rice to 25 persons of Siluvaipalayam and Vadalur villages.
- Mr. Prem, Providence Mall, Puducherry contributed 200 kgs of rice to 20 persons of Nangathur and Uluthur villages.
- The Principal, St. Patrick Higher Secondary school, Puducherry has donated 200 kgs of rice to 20 persons in Irrupukuruchi and Aarasakuzhi villages.
- SAMSON Shoes, Puducherry contributed 200 kgs of rice to 20 persons in Pudu Nagar and J.J. Nagar at Puducherry district.

Totally 1465 persons, 6418 family members received COVID 19 response kit through various funding agencies and volunteers. Also 70 family members benefitted through ChildLine Foundation, 200 beneficiaries benefitted through TASOSS, Trichy, 262 project beneficiaries benefitted through ChildFund India and 36 inmates received nutritional kits through DDRO, Villupuram.

1963 persons and 7476 family members benefitted through COVID 19 response







- During the reporting period, 4 cancer patients identified and 2 of them were referred to JIPMER hospital, Puducherry and also provided psycho social counseling to all cancer patients.

 240 family members established kitchen garden and produce the vegetables with organic manner.
- Established networks with 3 hospitals and 14 clubs.

3. LIVELIHOOD TRAINING CENTRE

The aim of Livelihood training Centre and Community Hall is to utilize them for the development of people's livelihood through trainings and meetings in the project areas and also utilize to conduct public functions.

Outcome / Developments:

- During the reporting period, a total of 94 Police Officers, Inspectors and Guards from Puducherry District Police Department stayed at the Livelihood training center for 14 days for Election work.
- 97 celebrations were organized; approximately 75 persons access the community hall per celebration.

4. FRATERNAL LIFE SERVICE HOME (FLSH):

Since 15th August 1983, Fraternal Life Service Home, a unit of PMSSS is providing rehabilitation through medicine, food, clothing, care and support service rendered for the mentally ill. The inmates from Puducherry and TamilNadu, Karnataka and West Bengal Districts were admitted and got treatment.

Momentous event:



Outcome / Development:

- 43 persons (23 men; 20 female) had treatment with the support of Doctors from JIPMER hospital and Karthikamam Government Hospital and resumed normal life.
- 113 persons from other districts got treatment and under follow up.
- 5 persons (1 men; 4 female) were cured to normal life.

Case study 1:


Mrs. Thaiyalnayaki, age 43, hails from Periyakannadi village of Kurunjipadi block, Cuddalore district. Her husband is Mr. Karthikeyan. Both of them are working as a coolie. They have 3 daughters, out of them 2 daughters got married and one daughter is working as a coolie. Mrs. Thaiyalnayaki was suffering from schizophrenia for the past 8 years and had treatment to private hospital and Cuddalore Government Hospital. But there is no improvement. At the 2019, she was admitted in our FLSH on 10th December 2019. Then, she was given continuous treatment every 15 days through JIPMER hospital and followed by counseling, yoga exercise, medicine and nutritional foods. Through FLSH staff efforts, she got cured and return back to home to live normal life. Now she is doing agricultural coolie and earns Rs. 2500 per month. She also arranged marriage for her third daughter and also she solved her financial problems and taking care of her family happily. Mrs. Thaiyalnayagi thanked for the support rendered by the PMSSS Director.

5. COMMUNITY HEALTH PROGRAM:

Since its inception from 1980, the primary focus of the program is to help the people of Pondicherry – Cuddalore Archdiocese and other dioceses to care and lead healthy life.

During the corona pandemic period, out patients were not strictly allowed in JIPMER Hospital till January 2021. In the meantime, the Government hospital also not allowed out patients except the emergency ward. At the juncture, medicine and counseling prevailed by TB patients and emergency cases. February 2021 onwards patients from project area got permitted with the concerned department and continued the necessary treatment.

Momentous event:





Outcome / Developments:

- During the reporting period, 48 persons from 7 districts got cured for various aliments under General Medicine, Gynecology, Eye, ENT, Skin, Cancer, Neurology, Cardiology and Paediatric.
- 14 patients from other dioceses like Trichy, Dharmapuri and Kumbakonam got cured of their diseases.
- Test for tuberculosis were conducted for 268 persons and 37 persons were found positive with tuberculosis and are under continuous treatment.

Case study 1:

Boy Naveen, aged 15 hails from Bhuvanagiri from Uluthur Parish. He is the second son of Mr. Mohan and Mrs. Vasanthi. His father died 5 years ago. His mother is a coolie, working in out of area. His grandmother's take care of the family and she is a member of women self-help group. Naveen completed his 10th grade and now is doing 11th grade. Due to his obesity he was taken to Chidambaram government hospital for treatment. After diagnosis, Doctors identified kidney problem and suggested to go treatment for Puducherry or Chidambaram hospitals. Then, his grandmother explained health issues to Mrs. Josphine Vanaja, Point person, PMSSS and request to guide for further treatment. The PMSSS point person contacted the PMSSS Health coordinator and explained Naveen's health issue over the phone.



Then, PMSSS health coordinator briefed the Naveen health issue to PMSSS Executive Director and his guidance he was admitted Puducherry Government hospital for treatment. As a result of Blood test, kidney test, ultra sound scan, found his kidney was not functioning properly. Due to inflammation urine was not coming properly and also kidney excreted more protein. As per doctor advice, proper treatment was given through drip for 10 days in the hospital. Through this treatment he was better and returned home. Every 15 days and two months once regularly did checkup for his kidney function and facilitate the medical counseling. Naveen and his family members thanked The PMSSS Director for the timely help.

Case Study 2:

Mrs. Mangalamary aged 55, belongs to Fathimapalayam Parish. Her husband Mr. Arokiyasamy aged 60. Both of them are coolies and living together with their poor earnings. They have a son and a daughter. Both of them got married and living separately. In this situation Mrs. Mangalamary was suffering from excessive bleeding for nearly six months. She underwent medical treatment in nearby hospitals. But her bleeding problems were not solved. The doctor advised her to take blood test and scan. At this juncture she met the Fathimapalayam Parish Priest and explained her health problem and her inability to spend money for her treatment.



With his recommendation she met with the PMSSS Director. Considering health Coordinator she was admitted in the JIPMER hospital. As a result of Blood test, MRI scan she was affected for cervix cancer. She underwent chemotherapy but there is no result. Finally as per the doctor's advice her Uterus was removed through surgery and back to home safely. Once in a month she was facilitated and undergoes medical treatment. Mrs. Mangalamary and her husband thanked the PMSSS Director for his support rendered.

6. CHILDLINE 1098

CHILDLINE 1098, is India's first 24-hour toll free number. Through this project, emergency phone outreach service for children in need of care and protection linking them to long-term service for children in need of care and rehabilitation under the age group of below 18 yrs. With support of Ministry of Women and Child Development, New Delhi the project is implemented in 560 places under the guidance of Childline India Foundation.


In Puducherry the project is implemented by Pondicherry Multipurpose Social Service Society (PMSSS) being the collaborative organization since 2011. More than 4000 children have been benefited from the project since its inception in Puducherry.

Momentous event:

Every year Childline project conduct Childline Friends campaign to commemorate the Children's Day celebration between 14th to 20th. In order to highlight this, on 13th November 2020, press meet was organized and the Director of PMSSS Rev. Fr. C. Joseph Arumaiselvam briefed the activities carried out by Childline 1098 in the year 2019 -2020, discussed the intervention cases, sharing the schedule of Dosti campaign and thanked the media persons for their outstanding support towards establishing child protection. Ms. Asokan, Director of Women and Child development, Puducherry was special guest and discussed with child protection and rights during the press meet.

Corona relief work and Awareness:

- With the support of Childline India Foundation (CIF) distributed dry ration kits such as (5 kgs of rice, ½ kg of dhal, ½ litre of cooking oil, 100 gram turmeric powder, 100 gram of chilli powder, 100 gram of mustard, 1 packet salt, 1 kg onion, 5 packets of milk powder) and sanitary items like bathing soap - 2 nos; mask 4 to 5 nos to 70 family members. PMSSS Executive Director distributed the kits and blessed the family members.
- 128 persons from Villianur, Thattanchavady and visitors from GH attended the


7. CI – CBRF DPO PROJECT :

The objective of the project is to improve the lives of 1565 people with disabilities and federation members in 3 communes of Villianur, Mannadipet and Bahour of Puducherry District through various government welfare schemes and its developmental aspects. In collaboration of Caritas India and CBRF, PMSSS has been working the project for past nine years.

Due to change made in FCRA by the Central Government, CBRF DPO project was over in the month of March 2021 at PMSSS. Hence, Caritas India took up this project directly and as per approval the project activities will be continued in the PMSSS operational areas.

Momentous event:

- On 8th July 2020, with support of Caritas India and Feeding India, Chennai distributed COVID 19 response kits to 85 PwDs such as 5 kgs of rice, ½ kg of dhal, ½ kg of sugar, 100 gram of turmeric powder, 100 gram of chilli powder, 1 washing soap, 1 bathing soap, 1 salt packet and 1 kg of cooking oil. PMSSS Executive Director blessed and distributed kits to PWDs.
- With the support voluntary organization such as Earam foundation, Annam foundation, Jolly Home, Rotary club, Government officials, political leaders and individual's distributed the COVID relief kits such as Rice, dhal, cooking oil, soap, washing powder, sugar, wheat flour, biscuits, vegetables and cooked food to 1200 PwDs, widows and BPL families. Also distributed Kabasura Kudineer (Herbal drink) to the community people at project villages.



Staff training:

During the Corona period, monthly review meetings and once in 6 months partners meeting was conducted by CBRF through online.

Outcome / Developments

- Through Aanaidhu Matrithiranalikal Maruvazhvu Iyyakkam, PMSSS received "Best NGO Award" presented by Former Social Welfare Minister Mr. Rajavelu to the Executive Director of PMSSS.
- In Puducherry District, 250 PwDs received Unique Disability ID, 183 persons have applied for the same, 20 PwDs certificates were renewed and 1 person received assistance for construction of toilet.
- 36 PwDs received three wheeler motor vehicles through MLA and MP funds.
- Through voluntary organizations, 400 PwDs received Saree, Pant and shirt, Bed sheet, hand watch, crutches for the blind persons. Through Sathiya Special School, 64 PwDs received materials such as crutches, chair and toilet chairs.
- 2 PwDs women are married to normal person and live happily.
- On 10.11.2020, one disabled children from J.J nagar is enrolled in normal school in 11th grade.
- Through PwDs federation, solved family problem of one disabled women and got sewing machine for their livelihood support through PMSSS.
- 8 memorandum have been passed through continuous struggles and effort of Puducherry PwDs federation members, the details are

Outcome / Developments

- o During Covid 19 situation, livelihood loan deduction in the monthly pension was suspended.
- o Provide the monthly 15 kg free rice allowance and disabled pension to be paid the 7th of each month.
- o Puducherry Government announced for cancellation of drinking water tax and free 100 unit electricity bill to the BPL family.
- o Consideration of increasing the monthly pension amount
- o Two Person with Disability members enrolled in the Economic and Social Justice Committee, Puducherry.
- o Provide Postal Vote facility to disabled.
- o Puducherry Government celebrated the World Disable Day on 26 th February 2021 and conducted sports event at Puducherry.
- On account of women's day celebration was held on March 8th 2021, CBRF honored and given title for "Mahila Sakthi " to Puducherry PwDs mother's (Mrs. Gomathi) and her daughter (Ms. Ester) through online.

Total number of recipients: 7825

Case study 1:

Mrs. V. Packiavathi, age 60, hails from Puducherry Nellithoppu. She was affected by polio when 4 years old, she became a Locomotor Disability – 100%. She married a normal person (without disability) and her parents not support her. Her husband Mr. Veerappan and he is doing wire chair making. Also he is doing buying up supplies at ration shop, taking water on tricycle, a person would pay 10 rupees for it. This amount would be used for family expenses by keeping the monthly allowance. She has a daughter and a son. Her family is economically poor. At this situation, her husband expired in 1991.



After her husband death, her family conditions were very worst situation. Through Government welfare scheme, she received wheelchair given by the Former Governor of Pondicherry. She has been running a petty shop for livelihood and the income has been utilized for children education and family needs. In 2000, became a member in Dr.B.R. Ambedkar Udal Unamutrore Ilaignar Narpani Mandram.

In 2016, she and her group members joined the Mainstreaming program. She received various trainings through this program and further developed her ability through PMSSS CBR-Mainstreaming and DPO project. The rights to be obtained through the social welfare department are the ones who can ask for privileges, in conjunction with the district federation, and through struggles. She received Government schemes. She received relief kits through PMSSS during the Corona Lockdown. This assistance was useful to her. She is currently making progress by selling groceries and stationery at the Petty shop. Now her children have married. Mrs. Packiavathi expressed her gratitude to PMSSS and CBRF for guiding her progress and self-sustain.

Case study 2:

Mrs. Susila, age 64, belongs to Puducherry Periyar Nagar Kathikamam. She has completed 8th grade. Her husband name is Mr. Radhakrishnan, age 74. They have been married for 47 years, happily running their family. After the wedding, when the couple went to relative's house for a party, Mrs. Susila leg was burned and crippled when she try to save the relative

child during the fire accident. She has admitted at JIPMER hospital for treatment. After 7 years treatment her leg partially treated through surgery and then she continue the work smoothly.

They have a daughter and got married in the age of 16. Her husband was searching for the missing grandchild for the last 5 years ago, he was met with an accident by lorry and lost his leg. After her husband accident, her family economic condition became worst. Then she is working a house maid and the income was to meet out her family needs and did small savings. Through her saving, her husband opened petty shop for their livelihood. Both of them became disabled.



Mrs. Susila and her husband joined PMSSS Mainstreaming project 4 years ago and improve their capacity building through various training and meetings. Also they started Annai Kasthuribai Physically Handicapped Social Service Center with 25 members for the development of PwDs. Through social service center, PwDs rights to be obtained through the social welfare department are the ones who can ask for privileges alone, in conjunction with the district federation, and through struggles. She has been face to face speaking with former Chief Minister of Pondicherry, political leaders and government officials about seeking rights for the disabled. She access to the NGOs and voluntary organizations to help people with disabilities and those living in poverty. She guided to get disability certificates and pensions to 100 disabled people. In the year of 2013-14 she received "Excellent Social Worker" award from Puducherry, Social Welfare Board and 3.12.2014 received Central Government "Excellent Social Worker" award at New Delhi.

8. CHILD DEVELOPMENT PROJECT:

Puducherry District covering Ariyankuppam and Nettapakkam communes. The main objective is to facilitate the project youth towards Livelihood, Child Protection and Sponsor Relation activities. In addition to this, during Covid 19 pandemic period the project beneficiaries were given awareness on protection from COVID 19 infection. Also the project distributed required groceries and hygiene kit to the beneficiaries and their families. ChildFund conducted various trainings and review meetings to the staff through online during pandemic period. But the project was over in November 2020 instead of the project period January 2021 due to the change made in FCRA by the Central Government. As a result the ChildFund Bangalore office could not fund the local partners due to FCRA changes. Hence, ChildFund International took up this project directly and PMSSS could not implement the project. The project was implemented from December 2020 to 31st March 2021 with minimum staff structure. The administrative change was informed by ChildFund to PMSSS.

COVID 19 Relief Activities:

The Government had announced full lockdown for the protection of public when the spread of Covid 19 reached the peak stage. At this stage, PMSSS in coordination with ChildFund India cook necessary steps to protect the project beneficiaries. For this purpose the ChildFund coproved the budget from the allotted fund of unspent budget of March 2020, April and May 2020 budget. The Commissioner of Ariyankuppam Commune Panchayat issued authorized centity cards to the staff to work in the service areas without any obstruction.

- Covid 19 awareness phamplets were distributed to the beneficiaries and public in the service areas.
 - During the first phase with the support of ChildFund, the Executive Director of PMSSS distributed food basket (rice 8kgs, toor dhal ½ kg, cooking oil -1/2 kg, sugar ½ kg, salt 1 no, turmeric powder 200 gram, chilli powder 200 gram, tea powder 4 packets) and hygiene kit (hand sanitizer 1 no, mask 4 nos, bleaching powder 1 packet, bathing soap 1 no, washing soap 1 no) to 214 project beneficiaries and 48 families in the service areas.

- The project gave hygiene kit (50 masks, 50 hand cloves and 5 hand sanitizers) to the frontline workers of Ariyankuppam Commune Panchayat through Mr. Soundararajan, Commissioner, Commune Panchayat. The Commissioner thanked PMSSS and CFI.

One of the project beneficiaries distributed 5kg rice bag each to 76 families in the service

areas and worth Rs. 10,000

- Since the lockdown continued the project wanted to support the beneficiaries (especially orphan, single headed families). This time 50 beneficiaries were supported with Covid 19 relief materials such as rice 6 kgs, wheat flour – 2 kgs, ragi flour – 1 kg, toor dhal – ½ kg, cooking oil – ½ kg, sugar – ½ kg, salt – 1 packet, biscuit packet – 2 nos and mask – 2 nos. The Executive Director of PMSSS distributed the relief materials to the beneficiaries from 29th August 2020 to 3rd September 2020.

The youth club members of Abishegapakkam, Thanampalayam, TN Palayam and Pooranankuppam in coordination with Government General Hospital medical team organized free Covid 19 screening camp. Through this camp Covid 19 screening test was conducted and those who found positive sent to hospital for treatment and returned home

safely after treatment.

- During Covid 19 pandemic period the youth club members of Pooranankuppam with the support of Legislative member distributed groceries and vegetable to the community people.

Momentous event:

- Under Livelihood project, 30 youth club members trained on formation of youth club federation, 204 project beneficiaries received training on "Promote development education kit" during September and October 2020. 30 youth club members sensitized on child protection and protection against vulnerabilities, 45 project beneficiaries participated in life skill education program. 31 beneficiaries received training on community based monitoring systems.
- 12 project children received skill trainings such as DCA, four wheeler and Tailoring course.
- 23rd October 2020, the Executive Director distributed education scholarship of Rs. 2000 each to 15 project beneficiaries perusing second year college education.
- 8 adolescent girls of the project who had tailoring training through project received free sewing machines on 30th June 2020 and 31st July 2020 respectively.
- During Covid 19 pandemic period the livelihood of the parents of project beneficiaries affected very much. Hence to support them, 3 persons for Tiffin shop, 4 persons for vegetable vending, 2 persons for idly floor selling, 2 persons for petty shop received Rs. 2000 /- each through entrepreneurship program from July to October 2020.
- **Under Child Protection Project,** 423 youth club members and communities knew about child protection issues, different types of Acts, how to use according to the situation and the roles and responsibilities of village level child protection committee.
- Meetings for 10 child protection committee members were conducted from 15.6.2020 to 28.6.2020. 106 CPC members participated in this meeting and knew about how the children were affected during Covid 19 pandemic period, how to approach legally for various issues and discussed about the number of vulnerable children identified through mapping.
- Training to identify vulnerable children through mapping was conducted for village level child protection committee members of 14 service areas during August and September 2020. 70 VLCPC members participated and identified 24 types of child protection issues.
- Based on the assessment for vulnerable children, the village level child protection committee members drafted an action plan during the months of September and October 2020. 109 VLCPC members participated and made the draft action plan.

77 letters wrote by the project beneficiaries and sent to their sponsors through CFI
In September 2020, Covid 19 response food basket survey was conducted with the project beneficiaries through CommCare app.

43 beneficiaries received money gift (DFC)
of Rs. 90,593.32 from their sponsors.
The project gift of Rs. 3760 was utilized
for awareness programs.

12 beneficiaries for various ailments (Cancer, heart problem, Epilepsy, PCOS, back pain, ulcer, joint treatment, Covid 19 affected and Nose surgery). Each received Rs. 1000 to Rs. 3000 on 29th May 2020 and 28th September 2020.

Two Sponsor Relation Committee meetings were conducted and during the discussion the project team explained the members, how the project supported the beneficiaries for the education, health and about project activities.

Beneficiaries of Government Welfare schemes:

- 5 persons in the service areas received Rs. 70,000 each under Puducherry Government free housing scheme through the facilitation of project staff.

Networking:

- The project team in coordination with a NGO organized free coaching for 30 students of 1st Std to 5th Std during Covid 19 pandemic period.
- The project team facilitated the mother of project child Kokulavasan (00832) for having free tailoring course through Indian Bank Skill training unit (INDSETI).

Outcome / Developments:

- The beneficiaries who received financial support for running Tiffin shop (3 persons) earn Rs. 300 per day, for vegetable vending (2 persons) earn Rs. 300 per day, for idly flour sales (2 persons) earn Rs. 150 per day and for petty shop (2 persons) earn Rs. 1000 per day through entrepreneurship program for livelihood development.
- 8 persons received sewing machines under livelihood development program earn Rs.
 500 to Rs. 1000 per day through part time job. This income really helps them to meet the family expenses and children's education.
- The youth those who completed four wheeler driving training work as part time drivers and earn Rs. 700 to Rs. 800 per day.
- The Village Level Child protection Committees (VLCPC) prevented two child marriages, rescued two child labour and prevented two children from community discrimination. Thus child protection issues reduced in service areas.
- Pooranankuppam youth club members distributed 150 masks to the MNREGA workers and 100 biscuit packets to the children worth Rs. 3200/-.
- Pooranankuppam youth club members in coordination with Dhanam Trust distributed masks to 100 families.
- The youth club members of Sada Nagar with the support of Ariyankuppam commune panchayat repaired drinking water pipeline.
- The youth club members of 14 service areas created awareness so that the project beneficiaries and public to stay safely during NIVAR cyclone.

Field visit by ChildFund International Zonal office representatives:

From 30.11.2020 & 1.12.2020, Mr. Anand, Sr. Manager – Livelihood, CFI visited the service areas and reviewed the project activities. He also interacted with PMSSS Chief Functionary about program activities. During the field visit he made assessment on various skill trainings required for the project beneficiaries and the houses affected by NIVAR cyclone. Based on the assessment he submitted a list on skill trainings for project beneficiaries and a list on restoring houses affected by NIVAR cyclone.

Total number of recipients: 48,923

Case study 1:

Child Subashini T (00543/100007772) has been the beneficiary of child development project for the past 16 years. Now, she has completed Bachelor of Technology (B.Tech). Since her parent 's economic condition is not sound, her maternal uncle taking care for the basic needs of her for many years. As a sponsored, child she attended many awareness programs, life skill programs and a member of youth club. She also received small amount of DF every year. These helped her to have overall development. In addition to this, with the support of project, she did tailoring course and received certificate. Through project she received food basket & hygiene kit during covid-19 lock down period.



The project has budget for child/youth towards business support and she applied for this. After proper scrutinization, she was selected to receive sewing machine, based on the economic condition and as semi orphan. Then she received sewing machine and started stitching as she has prerequisite skills. As she has enough time during this covid-19 lock down period, she stitches, blouse, chudithar and earns Rs.100/- to Rs.200/- per day. This helps her and her mother to manage the day today expenses. Previously she and her mother have to depend on her uncle's help. They feel very embarrassed to ask him and some time they have to bear with unnecessary words from him.

Now, this income really help Subashini and her mother to meet basic needs to some extent during this covid-19 crisis. From this income she does small savings for higher studies and buy materials for tailoring job. Subashini tells, "The support from the project in the form of a sewing machine really helps me as a livelihood support before I could find a job based on my educational qualification and tailoring job is an alternative source of income always". I thank CFI & PMSSS for the great help.

Case study 2:

E. Santhosh (00735/100020415) is an enrolled child of Child Development project for the past 17 years implemented by PMSSS since 2014 and supported by ChildFund India. He lives with his parents, elder sister and younger sister. His father is working as a Peon in a private company. His father's income is not sufficient to manage the entire family needs. His mother is a house wife and taking care of the children. Family's economic condition is very poor. The child Santhosh E is affected by Dyslexia (Learning Disability) & Heart Problem. His father has to spend for his treatment too.



The child Santhosh is doing 2nd year Diploma in carpentry and his elder sister got married and settled with her husband and his younger sister is doing 1st year Bachelor's degree in Economics. He is a member of Udhavum Karangal youth club of TN Palayam initiated by the project where the members are able to address social issues of their community and resolve them. During the COVID 19, TN Palayam youth club members distributed awareness notice on the adverse effect of Corona Virus to their community members and facilitated precautionary measures for COVID 19.


During the COVID 19 lock down, his family suffered a lot. His father was able to manage the family needs to some extent only, for some days only. In addition to this he has to pay the debt incurred for daughter's marriage (Santhosh's elder sister). His family unable to receive the relief of Rs. 2000/- given by the government as the amount was transferred to his deceased mother's (Santhosh's grandmother) account. Hence, he had to pledge the jewel to manage basic needs. As the lock down has been extended, his family suffered a lot without income.

At this juncture, Child Development Project implemented by PMSSS, distributed COVID 19 response kits such as food basket (Rice 8 kgs, dhal – $\frac{1}{2}$ kg, oil – $\frac{1}{2}$ kg, sugar – $\frac{1}{2}$ kg, iodised salt – 1 kg; turmeric powder – 200 grams, chilli powder – 200 grams and tea powder – 4 packets) and hygiene kit (hand sanitizer – 1 no; mask – 4 nos; soap – 2nos; bleaching powder -250 gram and detergent – 2 nos).

Santhosh's father told that, "I feel very happy that, we received this support at right time, not only this, I feel that, there is someone to help when we are in need". He also added that the groceries given will help us for some days to make food and hygiene kit to protect us from diseases. He thanked PMSSS, CFI for the timely help.

9. KOLPING MATRICULATION HIGHER SECONDARY SCHOOL:

Kolping Higher Secondary School started in the year 2004 for marginalized students to providing quality education, enhance their skills through various extracurricular activities. It is noteworthy that this school has been an excellent academy for financially backward students for the last 16 years.


10. KOLPING PROGRAMME:

Case Study 1:

Mr. Vijay Viknesh, age 23 lives at Thondananthal. His Father's Mr. Benjamin and his mother Mrs. Sagayamary. Both of them are agricultural labourers. His father is a member of St. Kuzhanthai Theresa kolping groups for past 17 years, now he became a president. His family is

living in very poor economic condition. His younger brother Albert, age 17 is studying 12th grade. The poor economic condition prevented to pay course fee for his MCA final year. Under this circumstance he approached the Kolping project coordinator, he had applied for loan under kolping vocational skill training assistance. Then he received Rs.20,000 assistance from kolping India and Rs. 15,000 loan from kolping groups, in total Rs. 30,000, completed his final year MCA in the year 2020. Then he applied for job in Kallakuruchi, Selam and Chennai. At this juncture, in September 2020, he got designer job at NINOS IT Solution, Chennai. Rs. 30,000 received as monthly income. Rs. 20,000 was sent to his parents through his income for some extent. The remaining amount, will plan to his younger brother studies. Now he is able to manage the family needs and developments. He thanked Kolping India and PMSSS for the support rendered.



Case study 2:

Mrs. Arockiaselvi, Age 47, hails from Sathamampattu. Her husband is Mr. Kuzhanthaisamy, age 55. Both of them are working as agriculture coolie. They have a son and he has completed Bachelors of commerce and searching for job. Mrs. Arockiaselvi is a member of St. Chinnappar kolping group since 2014. She saves Rs. 100 per month in a group. She benefitted from various meetings and trainings through project. She also participated milch animal rearing training organized by kolping project.



Then she applied for loan to purchase of milch animal through project. Then she received Rs. 20,000 assistance from Kolping India and Rs. 15,000 loan from Kolping group. In total Rs. 35,000 she bought a milch animal. After six months, has a Calf. The milch animal yields 5 to 6 litres per day from sells 5 litres and utilized 1 litre for their use. She earns Rs. 200 per day and per month she earns Rs. 6000, after expenditure she got Rs. 5400 as average income per month. This additional income helps her to meet her family needs. She thanked Kolping India and PMSSS for the support.

11. NEW THRUST PROGRAMME:

The project aims to develop of the marginalized people in the rural areas of Aathrikuppam, Panappakam, Manamthavizhindhaputhur and Siluvaipalayam belonging to the Cuddalore District and also at J.J Nagar in Pondicherry since 21 years.

The New Thrust Project ended with PMSSS since March 2021 as per New FCRA Rules and Regulations. Since April 2021, NTP is continued under Direct Funding and supervision of TASOSS.



Momentous event:








12. USHA SILAI SCHOOL:

PMSSS with the support of Usha International Ltd., New Delhi has been implementing Usha silai schools project in Puducherry of Puducherry District, Cuddalore, Villupuram and Kallakurichi Districts of TamilNadu since 2013. The main objective of this program is to promote women entrepreneurs who know basic tailoring skills thereby enhancing their life style and livelihood.

During Covid 19 pandemic period, the Silai Schools were not functioning due to the lockdown announced by the Government. As a result the livelihood of Silai School teachers became a big question mark. At this juncture, the Silai School teachers decided to stitch mask for their livelihood. Then, Usha International Ltd along with PMSSS shared IEC material through whatsapp to the Usha Silai School teachers. The Usha Silai School teachers lobbying with Government and other institutions stitched masks with the help of guide supplied by Usha International and earned something for their livelihood. In total 45,850 masks were stitched through all Silai Schools and each mask was sold from Rs. 5 to Rs. 15/-. The silai school teachers distributed masks on free of cost to the elders and frontline workers in their areas. Through selling of masks each silai school teacher was able to get income ranging from Rs. 250 to Rs. 6250/-during Covid 19 pandemic period.

On 23rd June 2020, 7 silai school teachers sent a filled in form to Usha International Office regarding necessary developments required through google forms.


In September 2020, Usha International Ltd., in coordination with Confederation of Women Entrepreneurs (COWE) collected information of the silai School teachers for E-marketing. Based on the information collected an E – market portal was created for the Silai School teachers Mrs. Metilda Mary- Eraiyur , Mrs. Irudhayamary – Thiruvandarkoil and Mrs. Sopia, Melvizhi in the first phase. Through this E-portal the Silai School teachers received orders and the average income for a dress is upto Rs. 1500/-.

In October 2020, Usha International Ltd., has planned to create a whatsapp group for all the teachers of Silai Schools. The whatsapp numbers of Silai School teachers with their consent sent to Usha International Ltd.

A virtual call was conducted on 9th November 2020 regarding the functioning of Usha Silai Schools, future of the schools and networking. The representatives of Usha International Ltd., Mrs. Mary Rupa Tete, Vice President, Mr. Alok Shukla, General Manager, Mr. Vadivelan Perumal, Coordinator and Rev. Fr. C. Joseph Arumaiselvam, Executive Director of PMSSS were present during discussion. PMSSS Executive Director interacted with them about the functioning of silai schools especially during the Covid 19 pandemic period. The Director also informed the Usha team that there is no feasibility for networking with Government and non-Government departments.

To enhance the income of the Silai School teachers, Usha International Ltd wanted to support them through Rural Business Division (RBD), an another unit of it. According to this plan the Silai School teachers will sell the products of Usha like ceiling fan, table fan, LED bulb, Iron, Mixie, Grinder and other products through this school. Income from the sales of these



products will be paid to Usha International Ltd. The teachers can have the profit. This program mainly focuses the income to the teachers but not commercially. Before starting up of this project, on 29th & 30th January 2021, a field visit was done by Mr. Balakrishnan, Senior Sales Manager of RBD, Mr. Uthirakumar, Assistant, RBD and Mr. Vadivelan Perumal, Coordinator of Usha International Ltd. They had discussion with the Executive Director of PMSSS and explained about the objectives of the project. In addition to this, they explained the objectives to the Silai School teachers and asked about their consent.

In continuation to this project activity, during February and March 2021, 10 Silai schools teachers from Villupuram and Kallakuruchi Districts and 7 Silai School from Cuddalore District were linked to RBD project. As a first phase 2 ceiling fans, 2 table fans, 10 LED bulbs, 2 Iron box and 1 mixie were distributed to each silai school. As per the guidance from the RBD staff each silai school teacher sells the products and earn an additional income of Rs. 2500/- to Rs. 3000/-. Every fortnight the RBD staff visits the schools and discuss about the sales, demand of the products and based on the need, the staff supplies products to the schools.

As per the facilitation of Usha International Ltd., Mrs. Kalaiselvi, the master trainer conducted training to women of Ariyalur district from 11th February 2021 to 19th February 2021 to start 10 new silai schools. Mrs. Kalaiselvi received Rs. 6300 as training fee.

During December 2020, silai schools were reopened but only few students came to the schools. At present 650 women taking part in the training in all districts.

Outcome / Developments:

- ✓ During pandemic period the school teachers got income from selling masks to Government and private institutions.
- ✓ Usha Silai School teachers get income to some extent even during the crisis.
- ✓ Usha Silai School teachers gained confidence that apart from regular income from the schools they can earn from selling other products.
- ✓ The school teachers are facilitated to do marketing as per the need of the hour.

Total number of Recipients : 2640 Case Study 1 :

Ms. Selvarani, hails from Pennadam village at Cuddalore District, age 38. After Selvarani's birth, father left their family to fend for themselves and his whereabouts are unknown till date. Selvarani was brought up, along with her 4 siblings taking care of her mother. Her mother shifted to her natal house and there she was supported by her brother; and also earned some minimal income through daily wages that she earned as a Coolie. Her family is economically backward. Selvarani has completed 8th grade and she did not continue the education due to her family situation. Then, she enrolled herself in a tailoring course of 6 months. After her course, she became a teacher at a tailoring school and worked there for 2 years –and she earned around Rs 300-500 initially. Her brother earned around Rs 7000 – 10,000 every month. Through this income, her mother managed the family needs. Selvarani is planning to open the shop for their skill.



PMSSS distributed the circulars about Usha tailoring training to the churches in their service areas. The Priest of church shared this message during Sunday mass. After hearing this she came to Puducherry and joined 7 days residential training conducted at PMSSS training centre, Puducherry. Through this training she learnt about types of blouse, chudithar through paper pattern and cutting methods, embroidery and sewing machine service techniques. After the completion of the training, she got USHA tailoring machine, certificate, advertisement board and established USHA at her residence on 5th April 2016. So far 102 women completed tailoring training. She charge Rs. 500 as course fee. Now she earns Rs. 6000 to Rs. 8000 per month through

stitching. Through this income, she is able to run the school, educate the sibling children's and meet the family needs.

"It would have been difficult for me to survive without tailoring. I have gained respect and trust within my family and community through Usha Silai School. I have become a role model for several women in my community, thanks to USHA and PMSSS."

Case study 2:

Mrs. Sophia, age 37, native of Melvazhi in Villupuram district. She studied up to 5th grade and could not continue the education after her mother's demise. Her father is a mason. Sophia has an elder sister and a younger brother. The income of the father is not enough to meet the basic needs of the family. At this juncture, her father remarried and has two sons. Then it is difficult for the father to run the family and education to the children is a big question mark. She does domestic chores till she completes 15 years of age. Meanwhile her elder sister got married and settled in Bangalore. With the support of her elder sister she finds a job in Bangalore and earns Rs.1500/- per month. She learns tailoring during weekends. Then she got married and went to Mumbai with her husband where her husband works as a lift mechanic.



Her husband is not sufficient to run the family, working a tailoring and earn Rs. 4000 as monthly income. At this situation, her husband died of heart attack when she was pregnant, her husband family as no one to support her. Then she came to her village and lives with her parents. She did not want to trouble her parents, she is working tailoring job nearby village with Rs. 300 income.

Sophia came to know about Usha Silai school through the village president. She came to Puducherry and attended 7 days residential training at PMSSS training Centre. She learnt how to stitch different types of blouse, kurti, children dress and embroidery. In addition to this she learnt paper pattern and sewing machine service. After the completion of the training, she got USHA tailoring machine, certificate, advertisement board and established USHA silai School at her residence in 2014. So far 134 women completed tailoring course. She charges Rs. 500 to Rs.1500 as course fee. Now she earns Rs. 15000 per month through stitching. She has been promoted as Master trainer for imparting Usha silai school curriculum to others silai school. She is also part of fashion label program. Also she is getting job order and gets additional income.

This income helps her meet her own needs like school establishment, family needs, child education, savings. She also purchased a piece of land and constructing house at the old house site of her parents. PMSSS-Usha Silai School opens up a successful chapter in my life where I could face the challenge with confidence and lead a life with hope.

13. Empowering Small and Marginal Farmers for enhanced household income and Food Security - Manos Unidas, Spain

This project was started in the month of January during the year 2019, by selecting 10 villages in Villupuram and Cuddalore districts, to uplift the livelihood development of 474 small and marginal farmers. Through this project two Agro hubs were established in Villupuram and Cuddalore districts.

- > Through the project trainings and Government facilitation, farmers will do organic farming methods and increase the production yield.

14. INFORMATION AND COMMUNICATIONS TECHNOLOGY:

The project aims to support the youth to enhance their skills and providing tailoring training to rural women at a low cost.

- The computer training centre, Tally, DCA, DTP, C+, C++, beautician, tailoring, Aari work and embroidery to unemployed youth and women at low cost. During the reporting period, 86 persons are undergoing tailoring training, 1 person undergoes beautician training and 17 persons are undergoing DCA and Tally trainings respectively.
- > The left out copies of personal identification proofs of 'Physically challenged persons' who receive Aids from the Government, were found and entered in Excel sheets and sent to DDRO in villupuram District.
- ➤ In order to receive the Corona Aid from the Government for 981 Physically challenged persons, their personal identification proof details have been uploaded through the 'Persons with Disability Registration App'.


